### WEBSITE TERMS & CONDITIONS OF USE

### 1. About the Website

- (a) Welcome to <u>www.octanics.com</u> (Website). The Website allows you to access and use the Octanics platform (Services).
- (b) The Website is operated by Octanics. Access to and use of the Website, or any of its associated products or services, is provided by Octanics. Please read these terms and conditions (Terms) carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood, and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.
- (c) Octanics reserves the right to review and change nay of the Terms by updating this page at its sole discretion. When Octanics updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

## 2. About the Website

You accept the Terms by remaining on the Website. Where the option is available in the user interface, you may also accept the Terms by clicking to accept or agree to the Terms.

## 3. About the Service

- (a) Octanics platform is cloud based software and applications.
- (b) Free Trial and Paid accounts are currently offered. You acknowledge and agree that the accounts offered, as well as the account features may change from time to time and may be governed by separate terms which apply specific to the account. Where special account-specific terms apply, you will be informed, and must accept those terms before you are given such an account. For the avoidance of doubt these Terms apply unless otherwise agreed or amended by account-specific terms.
- (c) Some accounts may be governed by separate Software Licensing Agreement with Octanics, which may amend the terms of use. For the avoidance of doubt these Terms apply unless otherwise agreed or amended by the terms of an applicable Software Licensing Agreement.

## 4. Acceptable use of the Service

- (a) Octanics platform, its related features, and website must only be used lawfully. Octanics reserves the right to suspend, cancel or otherwise deny access to users and accounts who use the service:
  - **a.** To engage in any act that would disrupt the access, availability, and security of Octanics platform and other Octanics services, including but not limited to:
    - i. Tampering with, reverse-engineering or hacking our servers.
    - **ii.** Modifying, disabling, or compromising the performance of Octanics platform or other Octanics services.

- **iii.** Overwhelming, or attempting to overwhelm our infrastructure by imposing an unreasonably large load on our systems that consume extraordinary resources.
- iv. Compromising the integrity of our system, including probing, scanning and testing the vulnerability of our system unless expressly permitted by Octanics.
- (b) For any illegal purpose, or to violate any laws, including and without limitation to data, privacy, and export control laws.
- (c) To stalk, harass or threaten users and any member of the public.
- (d) To misrepresent or defraud any user or member of the publish through phising, spoofing, manipulating headers or other identifiers, impersonating anyone else, or falsely implying any sponsorship or association with Octanics or any third party.
- (e) To access or search any part of the Service, or any other Service owned by Octanics other than our publicly supported interface, or otherwise allowed for in an applicable Software Licensing Agreement.
- (f) To post, upload, share, or otherwise circulate content in violation of Octanics platform's content policy.

## 5. Security and Data Privacy

Octanics takes your privacy seriously and information provided through your use of the Website and/or Services are subject to Octanics's Privacy Policy, which is available on the Website. The Privacy Policy also addresses Octanics's process, policies, and obligation in respect of Octanics platform security breaches.

### 6. Data Use

Octanics collects, stores and processes your data on Octanics platform. The data is used to provide Services to you, as well as to facilitate Octanics's business operations. The Privacy Policy outlined how your data is collected, stored, and processed by Octanics. The Privacy Policy also addresses Octanics's processes, policies, and obligations in respect of data encryption and removal requests.

### 7. Subscription to use the Service

- (a) In order to access the Services, you must first purchase a subscription through the Website (Subscription) and pay the applicable fee for the selected Subscription (Subscription Fee). After purchasing a Subscription, you will be considered a member ('Member').
- (b) In purchasing the Subscription, you acknowledge and agree that it is your responsibility to ensure that the Subscription you elect to purchase is suitable for your use.
- (c) Before, during or after you have purchased the Subscription, you will then be required to register for an account through the Website before you can access the Services (Account).
- (d) As part of the registration process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including but not limited to name, email address and credit card detail.
- (e) You warrant that any information you give to Octanics while completing the registration process will always be accurate, correct and up to date.
- (f) Once you have completed the registration process, you will be registered user of the Website and agree to be bound by the Terms ("User"). As a Member you will be granted

immediate access to the Services from the time you have completed the registration process until the subscription period expires (**Subscription Period**).

- (g) You may not use the Services and may not accept the Terms if:
  - a. You are not of legal age to form a binding contract with Octanics; or

### 8. Payments

- (d) You agree and acknowledge that Octanics can very that Subscription Fee at any time and that the varied Subscription Fee will come into effect following the conclusion of the existing Subscription.

### 9. Refund Policy

- (a) Octanics offers refunds in accordance with the Indian Consumer Law and on the terms set out in these terms and conditions. Any benefits set out these terms and conditions may apply in addition to consumer's right under the Indian Consumer Law.
- (b) Octanics will only provide you with a refund of the Subscription Fee in the event they are unable to continue to provide the Services of if the manager of Octanics decides, at its absolute discretion, that it is reasonable to do so under the circumstances. Where this occurs, the refund will be in the proportional amount of the Subscription Fee that remains unused by the Member (**Refund**).

## 10. Copyright and intellectual Property

- (a) The Website, the Services and all the of the related products of Octanics are subject to copyright. The material on the Website is protected by copyright under the laws of India and through international treaties. Unless otherwise indicated, all rights (including copyright) in the Services and compilation of the Website (including but not limited to text, graphics, logos, button icons, video images, audio clips, Website code, scripts, design elements and interactive features) or the Services are owned or controlled for these purposes and are reserved by Octanics or its contributors.
- (b) All trademarks, service marks and trade names are owned, registered and/or licensed by Octanics, who grants to you a worldwide, non-exclusive, royalty-free, revocable license whilst you are a User to:
  - a. use the Wbsite pursuant to the Terms;
  - b. copy and store the Website and the material contained in the Website in your device's cache memory; and

- c. print pages from the Website for your own personal and non-commercial use.
- (c) Octanics does not grant you any other rights whatsoever in relation to the Website or the Services. All other rights are expressly reserved by Octanics.
- (d) Octanics retains all rights, title, and interest in and to the Website and all related Services. Nothing you do on or in relation to the Website will transfer any:
  - a. business name, trading name, domain name, trademark, industrial design, patent, registered design, or copyright, or
  - b. a right to use or exploit a business name, trading name, domain name, trademark, or industrial design, or
  - c. a thing, system or process that is the subject of a patent, registered design, or copyright (or an adaption or modification or such a thing, system, or process). To you.
- (e) You may not, without the prior written permission of Octanics and the permission of any other relevant rights owners: broadcast, republish, up-loa to a third party, transmit, post, distribute, show, or play in public, adapt, or change in any way the Services or third-party Services for any purpose, unless otherwise provided by these Terms. The prohibition does not extend to materials on the Website, which are freely available for re-use or are the public domain.

## 11. General Disclaimer

- (a) Nothing in the Terms limit or excludes any guarantees, warranties, representations, or conditions implied or imposed by law, including the Indian Consumer Law (or any liability under them) which by law may not be limited or excluded.
- (b) Subject to this clause, and to the extent permitted by law:
  - a. all terms, guarantees, warranties, representations, or conditions which are not expressly stated in the Terms are excluded; and
  - b. Octanics will not be liable for any special, indirect or consequential loss or damage (unless such loss or damage is reasonably foreseeable resulting from our failure to meet an applicable Consumer Guarantee), loss of profit or opportunity, or damage to goodwill arising out of or in connection with Services or these Terms (including as result of not being able to use the Services or the late supply of the Services), whether at common law, under contract, tort (including negligence), in equity, pursuant to statute or otherwise.
- (c) Use of the Website and the Services is at your own risk. Everything on the Website and the Services is provided to you "as is" and "as available" without warranty or condition of any kind. ## 12. Limitation of Liability

- (a) Octanics's total liability arising out of or in connection with the Services or these Terms, however arising, including under contract, tort (including negligence), in equity, under statute or otherwise, will not exceed the resupply of the Services to you.
- (b) You expressly understand and agree that Octanics, its affiliates, employees, agents, contributors, and licensors shall not be liable to you for any direct, indirect, incidental, special consequential or exemplary damages which may be incurred by you, however caused and under any theory or liability. This shall include, but is not limited to, any loss of profit (whether incurred directly or indirectly), loss of goodwill or business reputation and any other intangible loss.

## **13.** Termination of Contract

- (a) The Terms will continue to apply until terminated by either you or by Octanics as set out below.
- (b) If you want to terminate the Terms, you may do so by:
  - a. not renewing the Subscription prior to the end of the Subscription Period;
  - b. providing Octanics with 14 days' notice of your intention to terminate; and
  - c. closing your accounts for all of the services which you use, where Octanics has made this option available to you.
- (c) Any notices pursuant to Clause 13.2 above should be sent, in writing, to Octanics via the 'Contact Us' link on our homepage.
- (d) Octanics may at any time, terminate the Terms with you if:
  - a. You don't renew the Subscription at the end of the Subscription Period;
  - b. You have breached any provision of the Terms or intend to breach any provision;
  - c. Octanics is required to do so by law;
  - d. the provision of the Services to you by Octanics is, in the opinion of Octanics, no longer commercially viable.
- (e) Subject to local applicable laws, Octanics reserves the right to discontinue or cancel your Subscription or Account at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Website or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts Octanics's name or reputation or violates or those of another party.

## 14. Indemnity

You agree to indemnify Octanics, its affiliates, employees, agents, contributors, third party content providers and licensors from and against:

- (a) all action, suits, claims, demands, liabilities, costs, expenses, loss and damages (including legal fees on a full indemnity basis) incurred, suffered or arising out of or in connection with your content;

# 15. Dispute Resolution

15.1 Compulsory:

If a dispute arises out of the related to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

#### 15.2 Notice:

A party to the Terms claiming a dispute (**Dispute**) has arisen, under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and action required to settle the Dispute.

#### 15.3 Resolution:

On receipt of that notice (**Notice**) by that other party, the parties to the Terms (**Parties**) must:

- (a) Within 28 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- (b) If for any reason whatsoever, 28 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that an appropriate mediator be appointed by the Octanics;
- (c) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as precondition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;
- (d) The mediation will be held in Ahmedabad, India.

### 15.4 Confidential:

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purposes of applicable laws of evidence.

### 15.5 Termination of mediation:

If 2 moths have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.

### 16. Venue and Jurisdiction

The Services offered by Octanics is intended to be viewed by residents of India. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of India.

### 17. Governing Law

The Terms are governed by the laws of India. Any dispute, controversy, proceedings or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed by, interpreted, and construed by, under the pursuant to the laws of India without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clauses is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

#### 18. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
